SCHOOL SUPPORT AND SERVICE CONTRACT

As parents, we realize we are responsible for our child's education. In sending him / her to Blessed Sacrament School, we contract with the school to share this educational responsibility. The tuition and fees we pay partially finance our child's education. The contributions of the members of Blessed Sacrament Parish, the contributions of the clergy, faculty and staff, as well as the fundraising activities of the students and their families will supplement to provide the total cost of the educational program.

1. I / We understand that the religious education of our child(ren) is the primary reason for sending him/her to a Catholic School and we will support the school's effort by weekly attendance at Mass and regular reception of the Sacraments so that our child(ren) may have a sense of the importance of faith and commitment in their lives and to participate in the religion program by working with and encouraging my / our child(ren) to make religion and Christian values a reality in their lives.
2. I / We will encourage my / our child(ren) by providing help and support in home study.
3. I / We will abide by the contents of the Parent and Student Handbook and to make my / our child(ren) aware of school rules and regulations.
4. All forms and records necessary to comply with School, Archdiocesan and State Regulations will be promptly completed and returned to the school
5. It is understood that tuition and fees cover on a part of the total cost of the education of our child(ren) and it is agreed:.
 - a) Regular and prompt payment of tuition and fees will be made.
 - b) Supports pledged through participation in fundraisers during the year and a fine of \$25.00 for any event that I / we have volunteered for and not participated in will be due and payable immediately.,
6. Active participation in our child's(ren's) education and activities is expected, and I/we promise our participation and support by:
 - a) Agreeing to attend at least two general parent meeting each year and to respond to all requests for conference times. I / we understand that failure to attend a General Meeting without an excuse accepted by the Principal will incur a \$25.00 fine.
 - b) I / We agree to complete 35 hours of service to the school, including the ten (10) Carnival hours and to pay the fee of \$250.00 which is our Family Pledge in lieu of the remaining 25 hours (due September 15th and December 15th.)

c) I / We agree to assist in fundraising activities in the school (i.e., Christmas Sales and the Spring Candy Sales (5 boxes per child) or pay a fee of \$125.00 per Fundraiser per child and to support the Fundraising efforts / activities throughout theyear. d) I / We agree to pay the Parent-Teachers' Guild Fee of \$20.00.

7. The School is authorized to give minor First Aid and to seek Emergency Medical Assistance for my / our child(ren) in the event of an accident..

8.
